Abstract: Len Colodny was born January 21, 1938 in Washington, D.C. He is a journalist and writer best known for his two books, *Silent Coup: The Removal of a President*, co-authored with Robert Gettlin, and *The Forty Years War: The Rise and Fall of the Neocons, from Nixon to Obama*, co-authored with Tom Shachtman. Colodny also maintains the website watergate.com. The collection is comprised of Colodny's research on the Watergate scandal and documents from the court case *Deans v. St. Martin's Press, et. al.*
